Description

Recycled interior acrylic primer-sealer and undercoater for new or acrylic painted surfaces. It can be used in any room of the house, for their walls and ceiling. Easy to apply, excellent adherence, non-splattering and excellent hiding capacities.

Color

Storage

Surface preparation is crucial and the successful outcome of your project depends on it.

All surfaces must be free from contaminants, mildew or peeled paint. Glossy areas have to be sanded to ensure a better adhesion.

Wash all surfaces to be painted with TSP (Trisodium phosphate) and rinse well.

Allow proper time for drying.

Gypsum: Plaster must be clean and dry before painting. Make sure all dust has been removed after sanding.

Bared wood (resinous): According to wood type (pine, spruce, cedar...) apply anti-bleeding primer.

Bared wood (non-resinous): Apply a first coat thinned 15%. Apply second coat as is.

New concrete, cement: New concrete must be dry before being painted. It must dry at least one month per inch of thickness. Wash with muriatic acid and rinse thoroughly. Apply one coat as is.

Latex painted surfaces: Apply as is.

Alkyd painted surfaces: Sand well, then clean for an optimized adherence, transition primer is recommended.

Application

Thoroughly shake the paint can and then use a stir stick to mix the content all the way to the bottom of the can. Use a synthetic paintbrush (nylon or polyester) or a 10 mm anti-lint roller. The primer must be diluted with water up to 10% ratio in order to use a sprayer and get an even spread.

Temperature must be between 50°F and 89°F (10°C - 32°C). The humidity level must be lower than 50% and the room must be well ventilated. Drying time may vary depending on temperature, air moisture and thickness of the paint applied.

Cleaning of tools

Clean with water and mild soap.

Instruction for maintenance

It is best to use a soft cloth or sponge and a mild household soap. Do not use abrasive cleaner and/or greasy soap. Rinse soap residue. To allow a full capacity of this paint, wait at least 3 - 4 weeks prior to a first wash or to test adhesion.

Description of necessary first aid measures
